Care Options:

☐ Extended Day (7am – 6pm).

The YMCA offers full-time (Monday to Friday) or part-time care to meet the needs of our families. Part-time care is offered as two (2) or three (3) set days per week and is based on space availability (we do not offer a one (1) or four (4) day week program). The set days cannot be changed or rotated as families are matched to make a Monday to Friday space.

Note: The fee for Full-Day care (8:30am to 4:30pm) for 6-12 year old is \$42.00 per day with care between 8:30am to 4:30pm. Extended Day Care hours are 7am to 6pm and the fee is \$52.00. The fee for Full-Day care for 3.8 to 5 year olds is \$18.43 per day (after CWELCC) with care between 8:30am to 4:30pm. Extended Day Care hours are 7am to 6pm and the fee is \$23.15 per day (after CWELCC).
